### HORSE OR PONY RECORDING

**There is a \$10 New Recording fee per horse/pony.** This is a one-time fee for the life of the horse/pony. **All owners of the horse/pony must be members in good standing for points to count.** If a previously recorded horse/pony changes ownership then the recording must be transferred to the new owner(s) for points to be valid. **There is a \$5 Transfer Fee for a previously recorded horse/pony.** Leasers are not considered owners unless the lease is recorded with the USEF. ## Membership Application Checklist



Before mailing this membership application did you:

**Fill in your Complete Name, Complete Address,  
and Phone Number?**

**Include your Date of Birth?**

(This is used to verify your membership category as well as to give you a unique ID within the NJHSA membership database)

**Include your Trainer of Record?**

(This is used to calculate the Trainer of the Year Award)

**Record all of the horses and/or ponies that you want to  
receive points with the NJHSA for the season?  
Even if you are a Lifetime Member?**

(This activates your horse/pony in the database and tells us to look for its points)

**Completely fill out all of the Horse/Pony information?  
Even if it is a previously registered Horse/Pony?**

(This way we can check your horse/pony against our past years' database and determine if it is indeed a previously recorded horse or pony. Some horses or ponies may share a name with another horse/pony but the rest of the information sets it apart as a different horse/pony)

**Make certain that ALL OWNERS of a Horse/Pony  
are active NJHSA members?**

(If you lease your horse/pony the actual owner must be an NJHSA member for the horse/pony to receive points in the Hunters or Jumpers. If there are multiple owners then ALL owners must be NJHSA members)

**Properly register your Farm/Stable/Corporation?**

(If the horse/pony you ride is owned by a Farm, Stable or Corporation (F/S/C) only the owner or a registered officer of the F/S/C may register it with the NJHSA. The F/S/C must be registered, and an owner/officer must be an active member of the NJHSA for the F/S/C's horses/ponies to receive points)
