HORSE SHOW OF THE YEAR

An award given to a show or show series nominated by the general membership, and then voted on as to deserve special recognition for a particularly outstanding effort in numerous categories such as facility, staff, scheduling, prizes, atmosphere, service, footing, rings, courses and more!

MEMBER'S CHOICE AWARD

An award given in recognition through nomination and vote to a person who shows dedication and outstanding effort in a "behind the scenes" way throughout the year.

TRAINER OF THE YEAR

Awarded to the dedicated trainers whose hard working students have accumulated the greatest number of points throughout the show year.

JUNIOR AWARD

To honor a junior member of the NJHSA who has exemplified and supported the NJHSA's commitment to sportsmanship and horsemanship. This award is selected through a nomination and vote of the general membership. A donation will be made by the NJHSA to the charity of the recipient's choice.

HIGH SCORE AWARD PROGRAM RULES

The NJHSA Board reserves the right to make final decisions relating to the interpretation of specifications and the adjudication of the High Score Rules and procedures.

GENERAL RULES

- Every class offered herein which is covered by the rules and specifications of the current United States Equestrian Federation (USEF) rule book will be conducted judged in accordance therewith.
- Throughout these specifications the definitions of Junior Rider, Adult Amateur and Amateur-Owner will conform to the definitions established by USEF:
 - a. Junior Rider: Has not reached his/her 18th birthday as of December 1 of the current Show Year.
 - b. Adult Amateur Rider: No longer eligible as a Junior Rider, and is an Amateur according to the USEF definitions.
- The NJHSA High Score Awards "Show Year" is December 1 through November 30, concurrent with the USEF/USHJA year.
- Riders, horses, and ponies are eligible for High Score Awards ONLY if they are registered with the NJHSA and application fees have been paid. Membership becomes effective upon receipt of a completed application and the appropriate fees by the Membership Secretary. NO POINTS WILL BE ACCRUED FOR RIBBONS WON BEFORE THE EFFECTIVE DATE OF MEMBERSHIP.
- In cases of multiple ownership of a horse or pony, at least one owner of record must be an NJHSA member for points to accrue.
- A transfer of ownership must be filed for a horse or pony that is already recorded with the NJHSA. Points will be awarded to the new owner only from the date the transfer fee and paperwork are received by the NJHSA.
- Stables, Farms, or Corporations who wish to register their horses and ponies must be registered as members. In addition, an officer of the Stable, Farm, or Corporation must be a Senior Member.
- For LEASED horses or ponies, the actual owner of the horse or pony must be an NJHSA member for points to accrue. Exception: leases recorded with USEF per GR1108 - A recorded horse must be shown under a lessee's ownership provided an official lease is registered with the Federation.
- Decisions to split, combine or cancel divisions or classes for Year End Awards will be made by September 1st of the show year. Such decisions will be made by the Executive Committee whose decisions shall be final. Such decisions will be announced to the membership by September 15th of the show year.
- Members found to have misrepresented themselves or their horses (i.e. rider's age, rider's eligibility, horse/pony size or age) will forfeit ALL points earned in the incorrect division. Thereafter, points will be awarded only in the correct division as eligible.
- If any member is suspended by USEF or the USHJA, the NJHSA will suspend their membership during the suspension period imposed by USEF such that no NJHSA points will be accrued by the member. Points will not be accrued by any horses or ponies owned by suspended members or their farms, stables, corporations or entities. Any disciplinary action by USEF resulting in revocation and/or redistribution of points will also be observed by the NJHSA.
- If a genuine error is made, the NJHSA Executive Board must be notified immediately, and the horse show management and exhibitors must follow the NJHSA Executive Board's decision on sanctioning the division, and any procedure for correction.

ANNUAL MEMBERSHIP FEES:

VALIDITY OF POINTS

NJHSA Rules and Specifications must be followed for points to count, this includes specifications regarding eligibility, fence height, age group, etc.

- THREE (3) entries must be awarded ribbons in each class for points to count. EXCEPTION: Mini-Stirrup Division - see divisions specifications for details.
- A competitor must be awarded a ribbon (1st-6th) a minimum of five (5) times in the division or class to receive a High Score Award for that division or class.
- A minimum of THREE (3) classes constitutes a division.
- All three classes must run for Championship and Reserve Championship Bonus points to be awarded. In Hunter Divisions the three classes must include an Under Saddle class, and in the Equitation Divisions the three classes must include a Flat class. Additional classes may be added at a management's discretion. The maximum number of classes which may be offered in a section is four if held on one day, five if held on more than one day.
- A Classic may not count toward the total number of classes offered to create a division, and will not be awarded NJHSA High Score points.
- In Hunter divisions, the horse/pony must show in at least one over fences class for the under saddle points to count for that horse/pony.
- If a division is offered, but one or more classes are not completed, points will be awarded in classes which are filled or completed.

COMBINING OF CLASSES AND DIVISIONS

COMBINING: Classes or divisions may be combined if there are fewer than three (3) entries in either class or division. (Combination of hunter or jumper divisions with fences of different heights or combination with non-NJHSA divisions is discouraged and may affect the validity of points for those combined sections. Show results must state the original division or class entered.

Classes or divisions may ONLY be combined as follows:

- Short Stirrup Equitation with Beginner Rider Equitation
- Short Stirrup Hunter with Beginner Hunter
- Low Children's Hunter with Low Adult Amateur Hunter
- Children's Hunter (horse or pony) with Adult Amateur Hunter
- Low Children's Equitation with Low Adult Amateur Equitation
- Schooling Hunter or Suitable Hunter with USHJA 2'6", 2'9" and/or 3' Hunters
- Hopeful Hunter/Schooling Hunter/Suitable Hunter may be combined into a single section or two sections as entries warrant.

SPLITTING OF CLASSES AND DIVISIONS

SPLITTING: Classes or divisions may be split as long as there are three (3) entries in any split section. Any entry may show in only one split section. Classes or divisions may ONLY be split as follows:

- Adult Amateur Hunter may split into age groups according to USEF Zone 2 Specifications
- Children's Hunter Pony may be split into height sections according to USEF Zone 2 Specifications
- Children's Hunter Horse may be split into age groups according to USEF Zone 2 Specifications
- Low Children's Hunter Pony from Low Children's Hunter Horse
- Children's Hunter Horse from Children's Hunter Pony
- Pleasure Horse from Pleasure Pony
- Children's Medal from Adult Medal
- Junior Jumper from Adult Jumper

MID-YEAR POINTS RECONCILIATION

The NJHSA Board has enacted a Mid-Year Points Reconciliation deadline. The date of this deadline is determined annually by the NJHSA Board, and is typically around June 15th for points accrued between December 1st through May 31st. An inquiry period of two weeks will be open before the Mid-Year Points Reconciliation, during which time an inquiry can be made for points to be reviewed and corrected as deemed necessary by the NJHSA Point Secretary. After the inquiry period has closed and the mid-year deadline has passed, points for the first half of the show year will be locked and cannot be changed for any reason. Any inquiries regarding points which are received by the inquiry deadline but cannot be reconciled by the cut-off date will be brought before the NJHSA Executive Board whose decision regarding the inquiry will be final. In no case will any inquiry remain open for more than 30 days past the cut-off date.

NJHSA POINT VALUE SYSTEM

Points will be awarded using the following table:

CHAMPION & RESERVE CHAMPION BONUS POINTS

CHAMPION BONUS POINTS: 10 points

RESERVE CHAMPION BONUS POINTS: 5 points

- Champion and Reserve Champion will be determined by the horse show according to USEF Rules regarding championships.
- Please note that Bonus Points for Champion and Reserve Champion DO NOT change with the number of entries.
- No bonus points will be awarded in any performance-based Championship class

DETERMINING SHOW DAY CHAMPION & RESERVE CHAMPION TITLES:

If division show day championship and reserve championship are not reported in the results submitted by show management, they will be determined using the following points table:

PROCEDURES FOR SHOW MANAGEMENT

The following rules must be followed for shows to carry NJHSA points, and for those points to be counted towards the High Score Awards program:

- Applications 14 days in advance of a show are appreciated. If a show runs a series, a single application for the series may be submitted. Series shows may be paid for individually within 10 days of the conclusion of the competition.
- The fee for carrying NJHSA points is \$100 per show. Shows running over multiple days need only pay a single \$100 fee. No credit will be given for classes canceled or not filled. If an entire show is canceled, management may apply to the NJHSA for credit toward a future show. Payment must be made online; no checks will be accepted. Online payment must be made at www.njhsa.org
- Results from the Show Secretary must be sent to the NJHSA Point Secretary within TEN (10) days of the date of the show.
- Points must be submitted to njhsa.points@gmail.com
- No points will be entered into the database until payment is received.
- All points must be submitted via email in either USEF format, or as an export from ShowPro software. A USEF compliant Excel template is available from the Point Secretary. Points submitted in any format requiring manual input by the Point Secretary will result in a \$50 fee being assessed to the show. The fee must be paid before points will be posted.
- The NJHSA Point Secretary should be included on the mailing list (electronic or hard copy) for shows.
- All NJHSA classes and divisions must meet minimum specifications or the points will not be counted. Prizelists must contain correct specifications. Points from non-conforming classes or divisions will not be counted regardless of the name of the class or division. This includes the combining of divisions that are not specifically permitted under NJHSA rules.
- NJHSA points can be offered at shows open to all entries. Shows that require a qualifying procedure to enter are not eligible to offer NJHSA High Score Award points (i.e. NJPHA Fall Finale, Outreach Festivals).
- Points will not be counted from other shows run on the same date as the NJHSA Annual Horse Show.



EQUITATION DIVISIONS

Mini Stirrup Walk-Trot Division

This is not a High Score Division. An Achievement Award for this division will be given to every rider who accumulates a total of 250 points. No Year End Champion or Reserve will be awarded, nor will placement awards be given to riders who do not reach the Achievement Award level. Once reaching a total of 250 points, a rider may continue to show in the Mini Stirrup Division, or may show in another division where eligible without losing his or her Achievement Award for the current show year.

If there are fewer than three (3) entries in a class, points will be counted on a reduced scale as follows:

1st place = 5 points, 2nd place = 3 points. No bonus points for Champion or Reserve Champion if there are few than three (3) entries in a class.

Open to riders 10 years of age or under as of the current show year. Once a rider competes in any class or division other than Mini Stirrup or Walk-Trot Equitation or Hunter, they are no longer eligible for Mini Stirrup Division.

The division must include at least three of the following classes:

- Walk-Trot Equitation
- Walk-Trot Pleasure
- Walk-Trot Figure 8 Equitation
- Cross Rails OR Cavaletti poles - 4 crossrails below 18". Management may choose whether to offer cavaletti or crossrails, but is encouraged to post the class description in the prizelist and/or online in advance of the show. Management is required to mark the judge's card with course description with the specifications of this class as, "cantering is NOT required".

Short Stirrup Equitation Division

Perpetual Memorial Trophy donated by Liz McFadden in memory of "Coco-Lossal"

Open to riders 12 years of age or under as of the current show year. Rider not to have shown over fences 2' or higher at any horse show. Riders may cross-enter into any other class or division where fences are under 2'. May only be combined with Beginner Rider Equitation Division.

- Walk-Trot Equitation
- Walk-Trot-Canter Equitation
- Equitation Over Fences - To be shown over a minimum of 4 fences under 2'. May be crossrails.

Beginner Rider Equitation Division

Open to riders of any age. Rider not to have shown over fences 2' or higher at any horse show. Riders may cross-enter into any other class or division where fences are under 2'. May be split into age groups if entries warrant. May only be combined with Short Stirrup Equitation. Classes should include:

- Walk-Trot Equitation
- Walk-Trot-Canter Equitation
- Equitation Over Fences - to be shown over a minimum of 4 fences at less than 2' in height. May be crossrails. Trotting anywhere on course will not be penalized.

Modified Rider Equitation Division

Open to junior and adult amateur riders on horses or ponies. Riders not to have shown in any class or division with fences 2'6" or higher as of December 1st of the preceding year. Riders may not cross enter into classes where fence height exceeds 2'3" at the same competition.

Classes must include:

- Modified Rider Equitation on the Flat - To be shown at the walk, trot and canter both ways of the ring.
- Modified Rider Equitation Over Fences (minimum of two, maximum of three at a one-day competition, four at a multi-day competition). To show over a simple course at 2'3". No combinations.

Low Children's Equitation Division

Open to junior riders. Riders may not cross-enter at the same show into any class or division where fences exceed 2'9". Division may be split into horse section or pony section. If the division is split, a rider may show in only one section at that show.

Classes must include:

- Low Children's Equitation on the Flat - To be shown at the walk, trot and canter both ways of the ring.
- Low Children's Equitation Over Fences (a minimum of two classes, maximum of three at a one-day competition, four at a multi-day competition). To be shown over a minimum of 8 fences with two changes of direction after the first fence. Fences 2'6" for horses, 2' for all ponies (Small, Medium and Large).

NOTE: Division may be split into horse or pony sections if entries warrant. Division may be combined with Low Adult Equitation if there are less than three entries in any section. This division may be split into Horses and Ponies for Year-End awards at the discretion of the NJHSA Board if participation warrants. Any decision to split, combine or cancel for Year End Awards will be made by September 1st of the current show year.

Low Adult Amateur Equitation Division

Open to Adult Amateur riders. Riders may not cross enter into any class or section at the same competition where the fences exceed 2'9". Classes must include:

- Low Adult Amateur Equitation on the Flat - To be shown at the walk, trot and canter both ways of the ring.
- Low Adult Amateur Equitation Over Fences (a minimum of two classes, maximum of three at a one-day competition, four at a multi-day competition) - To show over a minimum of 8 fences with two changes of direction after the first fence. Fences 2'6".

NOTE: If a show offers a Low Adult Medal class, points for ribbons won in that class **will be included** in the NJHSA High Score Award for the Low Adult Amateur Equitation Division. However the class will NOT be counted in the show day championship.

Children's/Adult Amateur Medal

Open to all Junior and Adult Amateur riders on horses. Points for this Year End Award may be accumulated from any equitation class with fences at 2'9"-3', including but not limited to the following classes: NJHSA or NJPHA Children's/Adult Medal, Marshall & Sterling Children's Medal, Marshall & Sterling Adult Medal, THIS Medal, and Ariat Adult Medal. If any Medal Class is combined with a class which includes ponies, points will be counted only for the riders on horses jumping 2'9"-3'.

NOTE: May be split into sections of Children's or Adult Amateur riders if entries warrant. This class may be split into Children's and Adult Medal classes for Year-End awards at the discretion of the NJHSA Board if participation warrants. Any decision to split, combine or cancel for Year End Awards will be made by September 1st of the current show year.

HUNTER DIVISIONS

All hunter divisions are to be judged on soundness, performance, way of going, manners and suitability.

Short Stirrup Hunter Division

Open to horses and ponies ridden by riders 12 years of age or under as of the current show year. Rider not to have shown over fences 2' or higher at any horse show. Riders may cross-enter into any other class or division where fences are under 2'. May only be combined with Beginner Hunter Division (Section A).

Classes to include:

- Short Stirrup Hunter Under Saddle - To be shown at a walk, trot and canter both ways of the ring. No more than 10 horses/ponies to canter at one time. No martingales.
- Short Stirrup Hunter Over Fences (a minimum of two, maximum of three). To be shown over a course of 4-8 fences less than 2' in height. Fences may be crossrails or verticals, no oxers.

NOTE: Short Stirrup Hunter and Beginner Rider Hunter may be combined if there are less than three entries in either section.

Beginner Rider Hunter Division

Open to horses and ponies ridden by riders of any age. Rider not to have shown in any class or division at any horse show where the fences are 2' or higher. It is required that course diagram and judge's cards include this specification: trotting on anywhere on course not to be penalized.

- Beginner Rider Hunter Under Saddle - To be shown at a walk, trot and canter both ways of the ring. No more than 10 to canter at one time.
- Beginner Rider Hunter Over Fences (a minimum of two, maximum of three) To be shown over a minimum of eight fences less than 2' in height. Fences may be crossrails or verticals, no oxers.

NOTE: Short Stirrup Hunter and Beginner Hunter may be combined if there are less than three entries in either section, trotting anywhere on course not to be penalized.

Low Children's Hunter Divisions

To be run in accordance with USHJA Zone 2 Specifications. Open to all junior riders mounted on horses or ponies. Riders may not cross enter at the same competition into the Children's Hunter, Pony Hunter or any class/section where fences exceed 2'9".

Classes must include:

- Low Children's Hunter Under Saddle - to be shown at the walk, trot and canter both ways of the ring
- Low Children's Hunter Over Fences (a minimum of two maximum of three). To be shown over a course of eight fences including two changes of direction after the first fence. Horses to jump 2'6", all ponies to jump 2' (small, medium and large).

NOTE: Division may be split into Low Children's Hunter Horse and Low Children's Hunter Pony sections, or may be combined with the Low Adult Amateur Hunter Division if there are less than three entries in any section.

NOTE: This division may be split into Horses and Ponies for Year-End awards at the discretion of the NJHSA Board if participation warrants. Any decision to split, combine or cancel will be made by September 1st of the current show year.

Children's Hunter Pony Division

Perpetual Memorial Trophy in memory of Lori Adamkiewicz, donated by the McDevitt family. Awarded to the overall High Score Children's Hunter (horses and ponies).

Open to junior riders. To be run in accordance with the current USHJA Zone 2 Specifications, including specifications regarding the number of classes which may be offered and splitting or combining of divisions.

Ponies must be in possession of a USEF Measurement card.

- Children's Hunter Pony Under Saddle - to be shown at the walk, trot and canter both ways of the ring
- Children's Hunter Pony Over Fences (a minimum of two maximum of three). To be shown over a course of eight fences including two changes of direction after the first fence. Large ponies to jump 2'6", small and medium ponies to jump 2'.

Low Adult Amateur Hunter Division

Memorial Challenge Trophy in memory of Marilyn Haggerty Blohm. To be awarded to the Low Adult Amateur Hunter Champion at the NHSA Horse Show.

To be run in accordance with USHJA Zone 2 Specifications. Open to Adult Amateur riders. Riders may not cross enter into any class or section at the same competition where fences exceed 2'9". Classes to include:

- Low Adult Amateur Hunter Under Saddle - to be shown at the walk, trot and canter both ways of the ring
- Low Adult Amateur Hunter Over Fences - to be shown over a course of 8 fences including two changes of direction after the first fence. Fences 2'6".

NOTE: May be combined with the Low Children's Hunter Divisions if there are less than three entries in any section.

Children's Hunter Horse/Adult Amateur Hunter Division

Perpetual Memorial Trophy for Adult Amateur Hunters donated by James Jones Lemmerman in memory of Grace Pratt Jones
Perpetual Memorial Trophy in memory of Lori Adamkiewicz, donated by the McDevitt family awarded to the overall High Score Children's Hunter (horses and ponies).

To be run in accordance with the current USHJA Zone 2 Specifications, including specifications regarding the number of classes which may be offered and splitting or combining of divisions.

Children's Hunter Horses: Open to Junior riders.

Adult Amateur Hunter: Open to Adult Amateur riders. Ponies may be shown by Adults, suitability to count.

- Children's/Adult Amateur Hunter Under Saddle - to be shown at the walk, trot and canter both ways of the ring
- Children's/Adult Amateur Hunter Over Fences (a minimum of two maximum of three). To be shown over a course of eight fences including two changes of direction after the first fence. Fences 3'.

NOTE: This division may be split into Children and Adult Amateurs for Year-End awards at the discretion of the NJHSA Board if participation warrants. Any decision to split, combine or cancel will be made by September 1st of the current show year.

OPEN HUNTER DIVISIONS:

Key West Memorial Trophy donated by Lisa Mende Senus in memory of "Key West", presented to the Highest Scoring Horse from the Hopeful, Schooling and Suitable Hunter Divisions.

NOTE: Hopeful, Schooling and Suitable Hunters may be combined if there are less than three in any one section, or split if there three or more in each section, but courses must meet specifications of their respective height section (i.e. no combinations for Hopeful Hunters).

- Under Saddle - to be shown at the walk, trot and canter both ways of the ring
- Over Fences (a minimum of two, maximum of three). To be shown over a course of 8 fences including two changes of direction after the first fence.

Hopeful Hunter Division

Open to all. Fences 2' or 2'3", no combinations permitted.

NOTE: USHJA 2' and 2'3" Hunter divisions will be counted for Hopeful Hunter points even if not specifically designated as such in the prizelist. May be split into two sections by height if entries warrant.

Schooling Hunter Division

Open to all. Fences 2'6".

NOTE: USHJA 2'6" Hunter divisions will be counted for Schooling Hunter points even if not specifically designated as such in the prizelist.

Suitable Hunter Division

Open to all. Fences 2'9" OR 3".

NOTE: USHJA 3' Hunter divisions will be counted for Suitable Hunter points even if not specifically designated as such in the prizelist. May be split into two sections by height if entries warrant.

Pleasure Horse or Pony Division

Perpetual Memorial Trophy in memory of James Jones Lemmerman, donated by his friends.

Memorial Challenge Trophy donated by Lisa Mende Senus in memory of "Goodbye Hollywood", presented to the Pleasure Division Champion at the NJHSA Annual Horse Show

Open to all horses and ponies. To be shown in English tack at a walk, trot and canter both ways of the ring. To be judged with emphasis on manners and suitability as well as soundness and performance. May be asked to back readily and stand quietly. No more than eight to hand gallop at the same time. No martingales. May be split into horses and ponies as two separate sections if entries warrant.

A minimum of three classes to be offered. Division may include Cross Country Pleasure that is to include at least one of the following tests:

- trot or canter over cavaletti
- trot or lead over small jumps
- back between two ground rails

JUMPER DIVISIONS

General Rules:

- All jumper classes meeting the specifications below (except Classics) will receive NJHSA Points regardless of the number of classes at the show.
- No NJHSA Champion or Reserve Champion Bonus points will be awarded in any Jumper Division.
- A Jumper Class need not be named exactly for points to count towards its respective High Score Award, as long as said class meets the height and spread requirements of the section.

Itty Bitty Jumper - 0.70m

Open to all horses and ponies who as a horse/rider combination have not won a lifetime total of \$1,000 in jumper classes as of December 1st of the current show year. All classes to be run concurrent with USEF Tables. Fences 0.70m in height; combinations are NOT permitted. Itty Bitty Jumper may NOT be combined with any other jumper classes where fences exceed 0.70m, but MAY be combined with other jumper classes where fences are lower than 0.70m if there are less than three entered in the class.

Low Preliminary Jumper - 0.80m-0.85m

Open to all horses and ponies. All classes to be run concurrent with USEF Tables. Fences to be set at .80m-0.85m. Any unrestricted jumper classes at this height will be counted for points regardless of the name of the class.

Junior/Amateur Jumper (formerly Children's/Adult Jumper)

Perpetual Memorial Trophy presented by E.J. Geiger in memory of "Clever Decision" to the overall high score Junior/Amateur Jumper

Separate High Score Awards may be given for each section (Low and High) if participation warrants. Decision to cancel, split or combine the high score awards to be made by the NJHSA Executive Board by September 1st of the show year.

To be run in accordance with USHJA Zone 2 Specifications. Fence heights:

- Low: 0.90-1.00m Junior/Amateur Jumper
- High: 1.10-1.15m Junior/Amateur Jumper
